The Tenderer must submit the Bid Document with required mandatory attachments as per continued in bid document

No Telegraphic, telephonic, telex, facsimile, e-mail and late tenders will be accepted.

Bids will be pre-qualified in accordance with functionality criteria as outlined in the tender. Only bids that meet the minimum number of points out of the total number of points for functionality will proceed to the price and preference points' evaluation stage. Tenders will be evaluated on the 80/20-point system in terms of Thaba Chweu Local Municipality's Supply Chain Management Policy in line with the Supply Chain Regulations and Preferential Procurement Framework Act 5 of 2000.

Tenders shall be deemed to have acquainted themselves with tender rules included in tender documents. Tenders shall be valid for a period of 90 days from the closing dates.

Bidders that fail to submit documents indicated as compulsory in the tender document will be disqualified.

No award will be made to a person who is in the service of the state, If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state, who is an adviser or consultant contracted with the municipality or municipal entity.

The Municipality reserves the right to withdraw any invitation to tender and/or re-advertise or to reject any tender or to accept a part of it. The Municipality does not bind itself to accept the lowest tender or award a contract to the bidder scoring the highest number of points.

**N.B:** Only locally manufactured or produced goods, meeting the stipulated minimum threshold for local production and content, will be considered in line with Regulation 8 (2) of the Municipal Supply Chain Management Regulations and Treasury Circular 69."

The exchange rate to be used for the calculation of local production and content must be the exchange rate published by the South African Reserve Bank (SARB) at 12:00 on the date of the advertisement of the bid; and

Only the South-African Bureau of Standards (SABS) approved technical specification number SATS 12863:2011 must be used to calculate local content.
