The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

Tenders shall be deemed to have acquainted themselves with tender rules included in tender documents. Tenders shall be valid for a period of 90 (Ninety) days from the closing dates. Bidders that fail to submit documents indicated as compulsory in the tender document will be disqualified.
